Sqt Tripp attended the meeting and gave the following report:

During April/May 76 crimes and 98 incidents had been reported compared to 157 crimes and 131 incidents in April/May 2023.

A burglary had been reported at Springfield Campus, no items were stolen, or any damage caused. On a separate occasion a purse had been stolen from the Campus.

An adult male had been arrested for being under the influence of drink and drugs whilst driving a motor vehicle and had been disqualified from driving. Two further adults had also been arrested for drink driving.

Criminal damage had been caused to a BMW in Priory Street; the tyres had been slashed.

There had been five motorcycle thefts and one attempted theft in Corsham. This was not just a local issue.

Councillors mentioned that the new 20mph limit in Neston was not being adhered to by some drivers, and that there was speeding in Katherine Park along the speed bumps. Police checks would be carried out in both locations.
