Stay Safe Initiative CIC – The Stay Safe Initiative is seeking £1,550 towards continuing its successful Digital Empowerment Programme for Year 7 and Year 9 students and their families at The Corsham School, enabling young people to have a more positive online life and to make healthy choices. The funding will also be used towards the new Boyz-2-Men course, developed by Stay Safe, aimed at young men at the school to help

them understand the maze of masculinity, with topics that address toxic online influencers, sexual harassment and male mental health. The course helps unlock the potential of boys who may not have positive male role models in their lives. The application is *attached – for consideration*.

- 6. Community Wellbeing Update (*Minute CS 06/24 and others*) The Committee will be updated on the Town Council's latest community wellbeing activities.
 - i) The Community Wellbeing Officer continues to visit and support a wide range of local groups and organisations. The most recent visits were to Hungerford House's 'Tea at 3'; Rethink Mental Health, Corsham Library and Corsham Foodbank.
 - ii) The Foodbank will be delivering packages for families in need over the summer on 22 July. They have had around 1,400 residents use the Foodbank over the last year about 10% of the Corsham population meaning around 4,000 people in total were supported. Referrals are received from a wide range of organisations. Future funding is being sought; last year the cost of paying the Co-Op for food vouchers was around £45,000.

Jo Hillier, from Warm and Safe Wiltshire, will be visiting the Foodbank on 30 July to offer support and information to users.

- The Dogs for Health team are getting closer to working in the Corsham community. Interviews took place at the Town Hall at the end of June with three more interested dogs and owners. There are currently around nine volunteers who could support people in and around our community. The charity will attend the Street Fair in September. The work will link with The Porch's social prescribing team. Funding is being sought, with the Town Council's investment likely to be around £1,000.
- iv) The Town Council has been working with the Good Practice Mentor Programme to bring free training to those in our community who work with older (50+) people. The mentors use the legacy, learning and resources from the Ageing Better programme (a seven-year project to reduce loneliness) to support organisations in reaching, connecting with, and empowering older people.

Good Practice Mentor Joanne Stapleton (Age UK Camden) has delivered an online workshop/session for stakeholders, facilitated by the Town Council, to support age-friendly groups and organisations on the ground to find and engage with the older people they would like to meet.

The tailored online workshop sessions provided practical 'pick-up and use' outreach tools and techniques to address barriers to finding and engaging harder to reach older people. Around 20 local groups and organisations were offered the session.

The Community Wellbeing Officer is organising further free outreach training from the Good Practice Mentors, who will be visiting Corsham on 9 September 2024. This training will be linked to encouraging people to come to a drop-in event at Corsham Library the following week.

- v) A youth-focused Community Wellbeing meeting was held on 8 July 2024. The Minutes will be distributed with the Members Information Sheet. The next Community Wellbeing meeting will be held in early autumn date and focus to be confirmed.
- vi) The draft Community Wellbeing Strategy for the Town Council, which will now include Corsham's Age-friendly Community work (*Agenda Item 7*), will be available for consideration at September's Committee meeting.

- 7. Corsham An Age-friendly Community (*Minute 07/24*) Cllr Brown and the Head of Community Services will update the Committee on the latest steps taken towards Corsham becoming an Age-friendly Community *for information and discussion*.
